

TERMS & CONDITIONS OF HIRE:

These are the Terms and Conditions of Hire of Inflatable bouncy castle and slides. Please read these carefully and sign at the bottom to signify that you acknowledge and accept these Terms and Conditions;-

"The Hirer" means the person or company named on the 'Hirer's Details form

"The Contract" means the contract for the hire of the Equipment by the Hirer

"The Equipment" means all the items belonging to Billaboing that are to be hired to the hirer.

THE HIRER will, during the period of the hiring, be responsible for the supervision of the Equipment, its care, safety from damage however slight of any sort, and the behaviour of all persons of all ages using the Equipment whatever their capacity, including proper supervision of children to ensure children under school age use the Equipment separately to older children or adults.

THE HIRER shall not use the Equipment for any purpose other than that described in this contract, and shall not sub-hire or use the Equipment or allow the Equipment to be used for any unlawful purpose or in any unlawful way.

THE HIRER shall be deemed to have inspected the Equipment (accessories included supplied) and to have agreed that it is supplied in good condition unless he/she brings to the attention of Billaboing when it is set up and checked by the Hirer when coming in to possession of the equipment and any faults have been noted by the Hirer.

PUBLIC LIABILITY INSURANCE is excluded in its entirety following any claim or injury to any third party or employee whether directly or indirectly related to the use of drugs and/or alcohol. Billaboing excludes any liability for injury loss or damage caused to any person using the equipment contrary to the terms & conditions of this contract.

IMPORTANT NOTICE: Provided that the equipment is used in accordance with the above guidelines and conditions of hire, those using the inflatable should do so safely. However, accidents can happen. Billaboing can accept no liability for injuries sustained or any other loss, howsoever caused, in the absence of the negligence of Billaboing or its employees. As the equipment will be in the Hirer's possession and control whilst in use rather than Billaboing, any liability for injuries or other losses caused other than in the circumstances described above rests with the Hirer. Accordingly, it is strongly recommended that the Hirer has adequate public liability insurance covering his or her liability arising from the use of the inflatable.

USER SAFETY

Ensuring the safety of the users is reliant on common sense and strict supervision by a competent adult at ALL TIMES.

1. No Shoes 2. No Food 3. No Drink 4. No Toys

- Ensure nobody with a history of back/neck injuries etc. is allowed to use the equipment or anyone feeling unwell.
- Before each play, make sure all mats are in place and a supervisor is present.
- To avoid injury ensure all users of the same age and size group use the inflatable at any one time.
- Adults are not allowed on children's inflatables other than for assistance.
- Never turn the fan on or off with users on it. Not only is it dangerous - it can permanently damage the fan which is costly to replace.
- Prevent children from going round the back so they can't tamper with fan. Block access if need be.
- No Climbing or sitting on walls
- Under no circumstances should any user attempt any somersaults or acrobatics.

STOP DANGEROUS PLAY IMMEDIATELY

ELECTRICAL EQUIPMENT

- Only use electrical equipment supplied by us, as all electrical equipment is fully tested to the appropriate Health and safety Guidelines by a qualified electrician and fitted with British Standard approved connections. ALWAYS contact us for further advice or replacement.
- The connections are splash proof and can be left out in wet weather although do not let them become submerged in puddles etc.
- No person is to interfere, adjust or repair any electrical item, even if qualified to do so. Failure to do this may result in additional cost for replacement / repair.

CARE OF THE INFLATABLE

- No Party Poppers or Silly String (can cause permanent staining)
- If it gets dirty (including face paints) then it can be wiped clean with warm soapy water (baby wipes etc.)
- Do not attempt to move / drag the inflatable in any way as this can seriously damage to the inflatable and associated equipment.

Any damage to the inflatable (including food, party popper, silly string stains) will incur repair or cleaning charges accordingly.

Failure to observe these Terms & conditions at any time during the hire period will render the Hirer liable for associated costs and could invalidate the Hirer's public liability insurance policy.

If unsure of how to use or operate this piece of equipment - do not use until demonstrated by a qualified member of Billaboing staff.
